







## **SPEAKER BIOGRAPHIES**

PROFESSOR MARCEL FRATZSCHER Ph.D. is President of DIW Berlin, one of the leading, independent economic research institutes and think tanks in Europe, Professor of Macroeconomics and Finance at Humboldt-University Berlin, and Chair of the German government expert committee on 'Strengthening Investment In Germany'. He is member of the advisory board of the German development, nonprofit Deutsche Welthungerhilfe and member of the supervisory board of the Hertie School of Governance. Marcel Fratzscher's work focuses on topics macroeconomics, monetary economics, financial markets and global economy. In September 2014, his book The Germany Illusion: Why We Overestimate Our Economy And Need Europe was published. In his recent book The Battle for Redistribution - Why Germany Is Becoming More Unequal (March 2016), he analyses the economic and social impact of the high and rising inequality in Germany. His prior professional experience includes work as Head of the International Policy Analysis at the European Central Bank (ECB), where he worked from 2001 to 2012; the Peterson Institute for International Economics in 2000-01; before and during the Asian financial crisis in 1996-98 at the Ministry of Finance of Indonesia for the Harvard Institute for International Development (HIID); and shorter periods at the Asian Development Bank, the World Bank and in various parts of Asia and Africa. He received a Ph.D. in Economics from the European University Institute (EUI); a Master of Public Policy from Harvard University's John F. Kennedy School of Government; a B.A. in Philosophy, Politics, and Economics (PPE) from the University of Oxford, and a Vordiplom in Economics from Kiel University. He is a European citizen, having grown up and having obtained his primary and secondary education in Germany.

PROFESSOR BRIGID LAFFAN is Director and Professor at the Robert Schuman Centre for Advanced Studies, European University Institute (EUI), Florence. She was Vice-President of UCD and Principal of the College of Human Sciences from 2004 to 2011. She was the founding director of the Dublin European Institute UCD from 1999 and in March 2004 she was elected as a member of the Royal Irish Academy. In September 2014 Professor Laffan was awarded the UACES Lifetime Achievement Award. In 2012 she was awarded the THESEUS Award for outstanding research on European Integration. In 2010 she was awarded the *Ordre national du Mérite* by the President of the French Republic. Her latest publications include her co-edited book *Core-periphery Relations In The European Union: Power And Conflict In A Dualist Political Economy* (Routledge 2016) and her edited special issue of West European Politics, *Europe's Union In Crisis: Tested And Contested*, 2016.

JACEK ROSTOWSKI was a lecturer at the School of Slavonic and East European Studies, UCL from 1988-1995. He was subsequently a professor of Economics at the Central European University in Budapest during 1995-2000, and head of its Department of Economics from 2005-2006. From 1997 to 2000, Rostowski was Chairman of the Macro-Economic Policy Council at the Polish Ministry of Finance, and from 2002-2004 was an Economic Adviser to the National Bank of Poland. Rostowski joined the Cabinet of Premier Donald Tusk in 2007, and served as Finance Minister of the Republic of Poland until 2013, including as Deputy Prime Minister in the final year. Currently he is Chairman of the Board of the 'Foundation for Contemporary Liberalism' in Warsaw. Rostowski has published around 40 academic papers on European enlargement, monetary policy, currency policy and the transformation of post-communist economies. He is the author of academic books including *Macroeconomic Instability In Post-Communist Countries* (1998).

## **CONVENORS**

**ADAM BENNETT** is Deputy Director of the programme on the Political Economy of Financial Markets (PEFM), an Associate of South East European Studies at Oxford (SEESOX) and the coordinator of its political economy work. He also lectures at Cardiff University. Prior to joining St Antony's College, Bennett worked for the International Monetary Fund (IMF) where he was Senior Advisor (aka Deputy Director of Department) in the IMF's European Department. Before that, he was Senior Advisor in the Middle East Department, and head of the IMF office in Cairo from 2000-2002. During the second half of the 1990s he was chief of the IMF's Stand-by Operations division, covering all the IMF's big ticket programs of that era. In his early career, Bennett worked for the UK Treasury (specialising in monetary policy and forecasting), and for two investment banks. Bennett's published work has ranged over macroeconomics, monetary economics and post-conflict economics. His most recent book is Remaking The Balkan Economy: Economic And Policy Foundations For Growth In South East Europe, co-authored with Russell Kincaid, Peter Sanfey, and Max Watson (2015). Bennett was educated at Cambridge University and the LSE.

THE MOST HON THE MARQUESS OF LOTHIAN PC QC DL (CHAIR) is the Chairman of Global Strategy Forum. Lord Lothian was first elected to Parliament as Michael Ancram in 1974. His political career included four years as the Political Minister in Northern Ireland responsible for the opening engagements with the IRA which eventually led to the Good Friday Agreement, Chairman of the Conservative Party for three years, and four years as Shadow Foreign Secretary and Deputy Leader of the Opposition. He continues to be involved in international conflict resolution. He co-founded Global Strategy Forum in 2006 and remains its Chairman. He was appointed to the House of Lords as a life peer in October 2010. He is a member of the Intelligence and Security Committee of Parliament.

**PROFESSOR DAVID VINES** is Acting Director of the programme on the Political Economy of Financial Markets (PEFM). He was Professor of Economics at the University of Oxford and a Fellow of Balliol until his retirement in 2016. He is Adjunct Professor of Economics at the Australian National University, and a Research Fellow of the Centre for Economic Policy Research. From 2008 to 2012 he was the Research Director of the European Union's Framework Seven PEGGED Research Program, which analysed Global Economic Governance within Europe. Professor Vines received a BA from Melbourne University in 1971, and subsequently an MA and PhD from Cambridge University. From 1985 to 1992 he was Adam Smith Professor of Political Economy at the University of Glasgow. His research interests are in macroeconomics, including financial frictions, fiscal and monetary interactions, and financial crisis. His recent books include: The Leaderless Economy: Why The World Economic System Fell Apart And How To Fix It (2013, with Peter Temin); The IMF And Its Critics: Reform of Global Financial Architecture (2004, with Christopher Gilbert) and The Asian Financial Crisis: Causes, Contagion And Consequences (1999, with Pierre-Richard Agénor, Marcus Miller, and Axel Weber).
